**DEEP pedagogical framework**

This framework, developed by White, makes use of brain-based learning theory to develop a pedagogical sequence for religious education that stresses the personal construction of meaning. DEEP is an acronym for four movements: Discernment: the generation of personal meaning and understanding; Enrichment: catering for

individualised learning; Engagement: a personal choice to be involved in learning;  
Participation: the communal dimension of learning.
